

DESCRIPTION

Exhibit A

All that part of the former Depot Grounds of the Chicago, Milwaukee, St. Paul & Pacific Railroad in the N $\frac{1}{2}$ NW $\frac{1}{4}$ Section 16-T101N-R15W, Mower County; described as follows:

Commencing at the northwest corner of said Depot Grounds, which point is 2100 feet west of the east line of the N $\frac{1}{2}$ NW $\frac{1}{4}$ of said Section 16 and 265.19 feet north of the centerline of the original main track of said former Chicago, Milwaukee, St. Paul & Pacific Railroad; thence South a distance of 36.00 feet, on the west line of said Depot Grounds, to the point of beginning;

thence East a distance of 1200 feet, on a line parallel with and 36 feet south of the north line of said Depot Grounds;

thence South a distance of 114.25 feet, on a line parallel with and 900 feet east of the east line of said N $\frac{1}{2}$ NW $\frac{1}{4}$ of said Depot Grounds;

thence Northwesterly a distance of 167.35 feet, to a point 69 feet south of the north line of said Depot Grounds and 1045.87 feet west of the east line of the N $\frac{1}{2}$ NW $\frac{1}{4}$ of said Section 16;

thence West a distance of 848.68 feet, on a line parallel with the north line of said Depot Grounds;

thence South a distance of 234.85 feet, on a line parallel with the east line of said N $\frac{1}{2}$ NW $\frac{1}{4}$, to a point on the south line of said former Depot Grounds;

thence West a distance of 205.45 feet, on the west line of said Depot Grounds, to the southwest corner thereof;

thence North a distance of 268.96 feet, on the west line of said Depot Grounds, to the point of beginning;
