

SPECIAL SESSION OF THE MOWER COUNTY
BOARD OF COMMISSIONERS

December 16, 2008

The Mower County Board of Commissioners in and for the County of Mower, Minnesota, met in Special Session December 16, 2008 at 8:30 a.m. at the Courthouse in Austin, Minnesota.

GENERAL:

Scott Baudler, representing the Bridge and Celeste LaMosse, provided an update on the activities and progress of the Bridge.

Commissioner Hillier moved and Commissioner Lang seconded to accept a donation in the amount of \$2,000 from the Wal-Mart Corporation to be used to purchase items for selected Mower County kids during the Shop with a Cop Event on December 18th. Motion carried.

Commissioner Tucker moved and Commissioner Lang seconded to approve prepayment for state contracted expenses, as well as costs associated with the Bridge clubhouse to utilize projected under spending of 2008 state mental health grant funds. Motion carried.

Commissioner Tucker moved and Commissioner Tollefson seconded to authorize the Human Service Director to sign a Memorandum of Understanding between Mower County and the Southeastern Minnesota Area Agency on Aging for the Provision of Transition to Housing with Services Consultation for the period from October 1, 2008 through September 30, 2009 and to issue payment in the amount of \$3,743.71 representing ½ of the grant amount received as designated by the Minnesota Department of Human Services. Motion carried.

Commissioner Tucker moved and Commissioner Hillier seconded to continue the provision of Semi-Independent Living Services and Extended Employment Services for a Mower County client whose Guardian has requested that case management services be discontinued. (Case #379359) Lang abstained. Motion carried.

Commissioner Hillier moved and Commissioner Tollefson seconded to authorize the Chair and the Director to sign the following Purchase of Service Agreements:

- a. Cedar Valley Services, Inc. – approve amendment to contract for Home and Community Based Waiver Services, effective October 1, 2007 to June 30, 2009.
- b. Family Focus – approve amendment to contract for Home and Community Based Waiver Services, effective January 1, 2008 to June 30, 2009.
- c. Mower County Attorney – renew contract for Fraud Prosecution Services, effective January 1, 2009 to December 31, 2009.
- d. Mower County Sheriff – renew contract for Fraud Investigation Services, effective January 1, 2008 to December 31, 2009.
- e. REM Woodvale, Inc. – approve amendment to contract for Home and Community Based Waiver Services, effective October 1, 2007 to June 30, 2009.
- f. Sue Stegenga – approve contract for Mental Health Case Management Services, effective January 1, 2009 to December 31, 2009.
- g. Workforce Development, Inc. – renew contract for MFIP & DWP Services, effective January 1, 2009 to December 31, 2009.

Motion carried.

Commissioner Hillier moved and Commissioner Lang seconded to approve the destruction of designated Agency files in accordance with DHS Rules and Regulations. All previously approved files have been destroyed. Motion carried.

Commissioner Lang moved and Commissioner Tollefson seconded to authorize the Director to sign a Memorandum of Understanding with Gary Corcoran, DBA, Quality Community Services to receive an advance payment toward the operation of The Bridge, (a consumer clubhouse), subject to refund, net of incurred costs, if a contract cannot be negotiated by February 1, 2009. Motion carried.

Commissioner Tucker moved and Commissioner Lang seconded to cancel the contract between Mower County and the Consumer Survivor Network of Minnesota, effective January 31, 2009. Motion carried.

SOCIAL SERVICE ACTIONS:

Commissioner Tollefson moved and Commissioner Hillier seconded to approve the Social Service Actions. Motion carried.

INCOME MAINTENANCE ACTIONS:

Commissioner Lang moved and Commissioner Hillier seconded to approve the Income Maintenance Actions. Motion carried.

Sara Moe, Legal Secretary, was recognized as Employee of the Month.

Paul Reuvers, counsel concerning the Robbins Block EAW, reported to the Board that five comments were received, four within timeframe for public comment and one not within the timeframe for public comment. Mr. Reuvers reviewed the EAW comments from the five interested parties and the County's responses. The Board had received all

information with their agendas. Mr. Reuvers stated that the Board had three options at this time concerning the EAW: 1) enter a negative declaration; 2) enter a positive declaration; or 3) perform further investigation. It was the staff's and the consultant's recommendation the County order a Negative Declaration on the need for an EIS.

RESOLUTION APPROVING A NEGATIVE DECLARATION ON THE NEED FOR AN ENVIRONMENTAL IMPACT STATEMENT FOR ROBBINS BLOCK PROJECT

On motion of Commissioner Tucker, seconded by Commissioner Hillier, the following Resolution and Findings of Fact were passed and adopted by the Mower County Board of Commissioners at a meeting held December 16, 2008 at the Courthouse, Austin, Minnesota.

WHEREAS, Mower County ("County"), acting pursuant to Minnesota Rules 4410.1100, Subp. 6 prepared an Environmental Assessment Worksheet ("EAW") to determine if the Robbins Block Project ("Project") has the potential for significant environmental effects; and,

WHEREAS, the County distributed the EAW for review by governmental agencies and the public in accordance with the requirements of Minnesota Statutes Chapter 116D and Minnesota Rules Chapter 4410; and,

WHEREAS, the 30-day comment period ended on December 3, 2008; and

WHEREAS, the County acknowledges the comments received during the 30-day comment period from the Minnesota Department of Transportation, Minnesota Pollution Control Agency, Minnesota Historical Society, Preservation Alliance of Minnesota and the Austin Main Street Project, Inc.; and,

WHEREAS, the County has not received any comments from the Petitioners or their representative; and,

WHEREAS, the County carefully reviewed the comments on the EAW, and has prepared specific written responses to them in accordance with the requirements of Minnesota Rules 4410.1700; and,

WHEREAS, the County finds that an Environmental Impact Statement ("EIS") for the Project is not necessary because: (1) the Project does not fall within a mandatory EIS category as set forth in Minnesota Rules Part 4410.4400; and (2) the Project does not have the potential for significant environmental effects according to the criteria and procedures set forth at Minnesota Rules Part 4410.1700.

NOW, THEREFORE, BE IT RESOLVED, that the Mower County Board of Commissioners make a Negative Declaration finding the preparation of an EIS is not necessary, adopts the Findings of Fact and Conclusions supporting the decision, and directs

staff to distribute this resolution and Record of Decision within five days and publish a notice of decision in the EQB Monitor in accordance with Minnesota Rules Part 4410.1700, Subpart 5.

IT IS FURTHER RESOLVED:

1. Departmental expenditures, except Personnel items, shall not exceed the approved budget. To provide flexibility to the department, the Budget Officer shall be authorized to amend line item budgets within a department, exclusive of personnel items, provided the total approved budget remains unchanged. All other budget amendments shall require County Board approval.

2. Personnel line items are based on position authorization listings and estimates of staffing needs developed during the budget preparation process. Any changes in payroll shall be subject to County Board approval through one of the following actions:
 - i. General salary adjustments authorized by the County Board;

- ii. Salary adjustments pursuant to union contract provisions or statutory requirements;
 - iii. Specific authorization to fill a vacancy, add a new position or change a position classification.
3. Expenditure of funds budgeted shall be subject to applicable statutory procedures requiring proposals or bidding and any proposed expenditure in excess of \$25,000 shall be subject to prior approval of the County Board.
 4. Department heads shall be responsible for maintaining sufficient internal departmental expenditure and receipt records to conform to requirements of this budget policy.

**RESOLUTION
IN SUPPORT OF THE BUY MOWER/GROW MOWER CAMPAIGN
PROMOTED BY THE AUSTIN AREA CHAMBER OF COMMERCE**

On motion of Commissioner Tollefson, seconded by Commissioner Lang, the following Resolution was passed and adopted by the Mower County Board of Commissioners at a meeting held December 16, 2008 at the Courthouse, Austin, Minnesota.

WHEREAS, the Mower County Board of Commissioners supports the Buy Mower/Grow Mower campaign of the Austin Area Chamber of Commerce, which asks citizens, businesses and organizations within Mower County to shift 10% of their currently out-of-area spending back to businesses within Mower County; and

WHEREAS, it is estimated that if local residents commit to spending 10% of their dollars in Mower County that they currently spend out of county, they would add over \$20 million to our local economy; and

WHEREAS, increased customer loyalty would strengthen our local economy, providing more jobs for area residents and a stronger tax base for needed services; and

WHEREAS, local purchases save time and money because travel to another community costs about 50 cents per mile each way, which is invaluable time away from work or home; and

WHEREAS, shopping locally reduces gas consumption, pollution, and our dependence on foreign oil; and
