RESOLUTION

On motion of Commissioner Ankeny, seconded by Commissioner Reinartz, the following Resolution was passed and adopted by the Freeborn Mower Counties Joint Ditch Board of Commissioners at a meeting held September 11, 2012 at the Government Center, Austin, Minnesota.

WHEREAS, the ditch inspector for Mower County has reported that repairs are necessary, or may be necessary, on certain ditches, and

WHEREAS, the Ditch Authority for Mower County finds there are sufficient funds to the credit of such drainage systems.

NOW, THEREFORE BE IT RESOLVED AND ORDERED that

1. The cost of said repairs or levy be apportioned and assessed pro rata upon all lands, corporations and/or municipalities which have participated in the total drainage benefits are therefore determined on the joint ditch #26 and in the following amount for estimated annual repairs to be levied as special assessment for payable 2013 tax year:

Mower County	\$75,000.00
Freeborn County	4,000.00

2. Set the annual 2013 budget at \$73,767.00 for Mower County expenditures. A full and complete copy of the budget is on file with the County Auditor/Treasurer.
