Motion made by Commissioner Glynn, seconded by Commissioner Gabrielson to approve the agenda with the addition of requested approval of a grant amendment for the Remote Electronic Alcohol Monitoring grant. Motion carried.

Updates were provided as to the amount of appeals presented at the local boards of review, a new requirement by the Department of Revenue on agriculture and commercial property sales and the annual department goals Ms. Kanne has developed for her office.
