# SPECIAL SESSION OF THE MOWER COUNTY BOARD OF COMMISSIONERS

May 12, 2015

The Mower County Board of Commissioners in and for the County of Mower, Minnesota, met in Special Session May 12, 2015 at 8:30 a.m. at the Government Center in Austin, Minnesota.

Motion made by Commissioner Gabrielson, seconded by Commissioner Glynn to approve the agenda. Motion carried.

A Request for Proposal document for Single Stream (sort) recycling was presented to the Board for its consideration. The Solid Waste Committee recommended that the Board approve the document with a few additional modifications as noted by the Public Works Director and to set a letting / deadline date for the proposals to be received in the office of Public Works.

Motion made by Commissioner Gabrielson, seconded by Commissioner Glynn to approve the document requesting bids for Single Stream (sort) Recycling with bids due by June 18, 2015 at 1:00 p.m. for consideration by the Mower County Board of Commissioners on June 23, 2015. Motion carried.

Dan Kane invited two Board members to attend a Community Conversation on topics of immigration and refugees to be held at the Ruby Rupner Auditorium on June 18 at 6:30 p.m. hosted by the Austin Human Rights Commission and Christ Episcopal Church. Mr. Kane also raised a safety concern for the neighborhood surrounding the Roosevelt Bridge and gang activity as evidenced in the graffiti on the bridge discussed at a prior Board meeting.

Mr. Dick Brekke inquired about the possibility of single sort recycling for businesses. He was informed that the RFP approved by the board was for residential service but requested that the service be made available directly to business by the successful bidding hauler.

The Special Session of the Board was recessed at 8:59 a.m. and convened as Human Services Board at 9:00 a.m.

Motion made by Commissioner Gabrielson, seconded by Commissioner Glynn to solicit requests for proposal (RFP) from agencies that are qualified and willing to provide Rule 25 Assessments/Rule 24 Financial eligibility to residents of Mower County. Motion carried.

WHEREAS, UCare and Blue Plus have submitted proposals suitable to meet our needs.

THEREFORE, BE IT RESOLVED that the Mower County Board of Commissioners supports the recommendation of Mower County Health & Human Services approving UCare and Blue Plus as Managed Care Organizations (MCO(s)) providing managed health care services in Mower County.
