The Board held a discussion concerning Pictometry including a cost analysis, its usefulness in comparison to its cost and other possible uses of the funds in the land records fund.

Motion made by Commissioner Bennett, seconded by Commissioner Gabrielson to approve the agreement between Pictometry International Corp, Minnesota Counties Computer Cooperative and Mower County for an eight year pictometry project at an approximate cost of \$192,000.00. The Commissioners voted as follows: Commissioner Gabrielson aye, Commissioner Glynn aye, Commissioner Reinartz nay, Commissioner Bennett aye and Commissioner Ankeny aye. Motion carried 4-1.

There was a discussion concerning the public works / road and bridge budgets and the proposed use of the 2015 fuel savings for equipment and other proposed 2015 budget amendments for the department.

NOW, THEREFORE, BE IT RESOLVED, that the Jail Inmate Checking Account be established as the proper account to receive revenues and disburse payments.

Donna Welsh, Finance Director, provided information and a proposed revision on the process of approving and issuing duplicate check requests. The current practice to issue duplicate checks can result in unintended financial hardship to the recipient due to the various approvals required and the time to receive the approvals. The Finance Director has reviewed the process and is recommending the Board approve a new procedure which also includes necessary checks and balances to the process. Approval of the new procedure will

eliminate the need for formal County Board approval of individual requests and shall serve to reduce unnecessary delays when issuing duplicate warrants.

RESOLUTION

On motion of Commissioner Glynn, seconded by Commissioner Reinartz, the following Resolution was passed and adopted by the Mower County Board of Commissioners at a meeting held December 29, 2015, 2015 at the Government Center, Austin, Minnesota.

WHEREAS, the general public and vendors who do business with Mower County upon discovery of a missing or lost check currently have to submit an application and affidavit to the County Board for approval; and

WHEREAS, the current approval process can cause financial hardship to the recipient of Mower County funds due to frequency of scheduled County Commissioner meetings;

NOW THEREFORE BE IT RESOLVED, that the Mower County Board of Commissioners do hereby approve a new procedure to the issuance of duplicate checks as follows:

1. The vendor or citizen shall complete an application form, approved by the Finance Director, or his/her designee, and submit the application to the Finance Director, or his/her designee.
2. The Finance Director, or his/her designee, shall confer with County bank reconciliation staff to determine if collection of a stop payment fee is required. A stop payment fee will not be required if finance and bank reconciliation staff determine that overpayment can be recollected by the county through alternative methods. All occurrences where a stop payment fee is not required shall be documented and submitted to the County Board on a quarterly basis for review, but shall not require additional approval.
3. The vendor or citizen shall also sign a statement on the application that funds can be recollected should a lost or missing check be cashed or deposited whether accidentally or purposefully.
4. The Finance Director, or his/her designee, and county bank reconciliation staff shall approve the issuance of a duplicate check and shall submit a quarterly report to the County Board.

BE IT FURTHER RESOLVED, that all applicants for duplicate checks shall be required to enroll in the ACH payment process for future disbursements of county funds; and

BE IT ALSO RESOLVED, that this new procedure shall be effective upon the date of adoption.
