RESOLUTION

Establishing Findings of Fact and Granting a Waiver from the Solid Waste Management Ordinance for SKB Lansing Landfill

On motion of Commissioner Glynn, seconded by Commissioner Gabrielson, the following Resolution was passed and adopted by the Mower County Board of Commissioners at a meeting held March 3, 2020 at the Government Center, Austin, Minnesota.

WHEREAS, Mower County is a political subdivision organized and existing under the laws of the state of Minnesota; and,

WHEREAS, the Mower County Board of Commissioners has adopted a Solid Waste Management Ordinance (ORD-21) establishing authority for the entire County; and,

WHEREAS, Section 8.2(B) states that development of a solid waste landfill shall not exceed final contours of a minimum 2% and a maximum of 20% slope over entire fill for solid waste landfills; and,

WHEREAS, On December 10th, 2018, SKB Lansing submitted an Ord-21 Application for Waiver or Modification to allow an increase to final cover slopes from currently permitted 5H:1V (20%) to a proposed 4H:1V (25%); and,

WHEREAS, the Minnesota Pollution Control Agency (MPCA) has also reviewed the proposed change in slopes from 5H:1V to 4H:1V and public noticed a permit that approves of the slope change; and,

WHEREAS, Pursuant to Section 3.6 of Ord-21, the County Board may waive or modify the strict application of the provisions of Ord-180.

NOW, THEREFORE, BE IT RESOLVED, that the Mower County Board finds:

- 1) That the request is reasonable and meets the intent of this ordinance due to: *The intent of Ord-21 is to protect public health and the environment. SKB is requesting an increase in final cover slopes to maximize the waste disposal capacity for the permitted footprint, rather than permitting additional acreage. The volume increase provides for approximately 540,000 cubic yards.*
- 2) That such requirements are unnecessary or impractical in light of the applicant's proposed operation due to: *By requesting a Waiver, SKB proposes an increase in volume on their existing footprint instead of seeking a horizontal expansion. Further, SKB is required to also obtain a variance from Minn. Rules and has demonstrated through their variance request that constructing and maintaining 4H:1V slopes can be done without any adverse impacts to the environment.*

- 3) That the waiver or modification will not adversely impact human health or the environment due to: The purpose to the maximum of a 20% slope is to ensure stable side slopes, and that such slopes can also be maintained long term. SKB's MPCA variance request provided various stability calculations and reasonable justification that a 4H:1V can be built and maintained without posing a threat to human health or the environment.
- 4) That the request will not adversely affect the County's ability to monitor and enforce compliance with ORD-21 and the applicant's license due to: An increase from 5H:1V to 4H:1V will not prevent the County to monitor and enforce ORD-21. Such an increase to side slopes will not interfere in the County's ability to conduct site inspections to ensure compliance with the ORD-21 and the landfill's license.

BE IT FURTHER RESOLVED THAT THE MOWER COUNTY BOARD OF COMMISSIONERS: Grants a Waiver to SKB Lansing Landfill, in accordance with Section 3.6 of ORD-21, to allow for an increase in final grade slopes from 5H:1V (20%) to 4H:1V (25%) with the following conditions:

- 1) Applicant shall comply with and maintain compliance with, ORD-21, County License, and all applicable Minn. Rules.
- 2) This waiver allows for the increase in final grade slopes of 4H:1V as depicted in drawing C-104 (Final Contours) of License Document #2; construction of a slope steeper than 4H:1V will require another waiver application and approval from the County Board.
- 3) Applicant shall immediately notify the County of erosion, side slope failure or slumping, leachate seeps, or any other adverse impacts.
- 4) All conditions shall apply in full force and effect to any successor in interest to the property.

WHEREAS, Financial assurance requirements for SKB Lansing Landfill is a \$350,000 surety bond payable to the County; and,

NOW THEREFORE, BE IT RESOLVED, the Mower County Board of Commissioners hereby grants WCI Austin Landfill, LLC, a Solid Waste License for SKB Lansing Landfill as drafted by the Department and approved as to form by the County Attorney, providing operation of a Demolition Debris Landfill, Recycling Activities, and including a slope waiver, all as described in their License, with a term that will expire on March 31, 2021.

Justin Hanson and Mike Merten on behalf of the Cedar River Watershed District Board presented the board with the annual program update. Update highlights included flood mitigation success stories; rainbow trout coming to Wolf Creek; and a developing

partnership with the Welcome Center to bring fishing education to underserved sectors of the community.
