**COUNTY OF MOWER NOTICE OF OFFICES TO BE VOTED FOR AT THE STATE GENERAL ELECTION**

NOTICE IS HEREBY GIVEN, as provided in 204B.34, Minnesota Statutes, that the terms of the following named officers will expire on the first Monday in January, 2017, and that successors to the said officers are to be voted for by the electors of your city or township at the General Election to be held on Tuesday the 8<sup>th</sup> day of November, 2016

The filing period for the offices of United States Representative, Associate Justice of the Supreme Court, Judge of the Minnesota Court of Appeals, and Judge of the District Court begins at 8:00 am., Tuesday, May 17<sup>th</sup>, 2016 and ends at 5:00 pm., Tuesday, May 31<sup>st</sup>, 2016. Note the filing offices will be closed Monday, May 30<sup>th</sup>, 2016 in observance of Memorial Day and filing offices will be closed Monday, July 4<sup>th</sup>, 2016 in observance of Independence Day.

The place for filing for federal offices is the Office of the Secretary of State, State Office Building, Room 180, 100 Rev. Dr. Martin Luther King Jr. Blvd., St. Paul, MN 55155-1299. The place of filing for state offices is with the Office of the Secretary of State or with the Mower County Auditor-Treasurers 201 1<sup>st</sup> St. NE. Ste 5, Austin MN 55912, if the candidate resides within Mower County.

Candidates may file in person or by mail. Candidates who will be absent from the state during the filing period may arrange to file in person, prior to departure.
