



THE GARDEN OF THE GOOD SHEPHERD



SURVEYOR'S CERTIFICATE

I, JOHN J. KERR, SURVEYOR, DO HEREBY CERTIFY THAT THE FOREGOING PLAT IS A CORRECT MAP OF GARDEN "B" AND THE EAST 150.79 FEET OF GARDEN "C" OF GRAND VIEW MEMORIAL GARDENS, SITUATED IN THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 14 TOWNSHIP 102 NORTH RANGE 18 WEST IN MOWER COUNTY, MINNESOTA, AS SURVEYED AND LAID OUT BY ME UNDER THE DIRECTION OF THE BOARD OF TRUSTEES OF THE GRAND VIEW MEMORIAL PARK ASSOCIATION INCORPORATED, SAID PORTION TO BE KNOWN AND DESIGNATED AS "THE GARDEN OF THE GOOD SHEPHERD", THAT THE PLAT IS A CORRECT REPRESENTATION OF SAID SURVEY AS MADE, THAT THE SIZES OF ALL LOTS ARE AS SHOWN BY THE TYPICAL LOT SECTION, THAT ALL WALKS, DRIVEWAYS AND BORDER SECTIONS HAVE THE CORRECT DIMENSIONS GIVEN ON THE PLAT, THAT MONUMENTS FOR THE GUIDANCE OF FUTURE SURVEYS HAVE BEEN PLACED IN THE GROUND AT THE POINTS INDICATED THUS (O); THAT OUTSIDE BOUNDARY LINES ARE DESIGNATED ON SAID PLAT.
