



MAPLEVIEW VILLAGE


C.L. NORTH PARK AVENUE

CERTIFICATE

This is to certify that the Austin Cemetery Association, owner of all that part of the Northwest Quarter of the Northeast Quarter of Section No. 34, Township 103 North, Range 18 West, to wit: First considering the West line of the said Northwest Quarter of the Northeast Quarter of Section 34 to course due South from the Northwest Corner thereof; thence running due South from the said Northwest Corner thereof and along the said West line 923.00 feet; thence due East 33.00 feet to the Point of Beginning at the Northwest Corner of the Tract to be described; thence continuing due East 266.00 feet and along the South line of North Park Avenue in The Village of Mapleview and to the Northeast Corner of the Tract being described; thence due South 109.00 feet; thence due West 61.00 feet; thence Southwesterly 191.54 feet along a curve to the left of 141.00 feet radius and through a central angle of 77°50'; thence Southwesterly 33.96 feet along a curve to the right of 25.00 feet radius and through a central angle of 77°50' and to the end point of said curve; thence due West 42.37 feet and to the Southwest Corner of the tract being described and being 33.00 feet due East of the said West line of the Northwest Quarter of the Northeast Quarter and 240.00 feet due South of the Point of Beginning; thence due North 240.00 feet and along the East Right-of-way line of State Trunk Highway No. 218 and to the Point of Beginning, being and containing 0.952 Acres according to the survey thereof, has caused the said lands to be surveyed and platted into Grave Lots and Facility areas, according to the attached Plat, all in the said Northwest Quarter of the Northeast Quarter of Section No. 34, Township 103 North, Range 18 West, of the Fifth Principal Meridian, Mower County, Minnesota.
